DISPLAY FIREWORKS ORDERING INFORMATION

• Individuals or corporations must have an ATF Explosives or Fireworks License or Permit to purchase Display Fireworks.

ATF regulations and applications are available from the ATF Explosives Licensing Center, Phone 877.283.3352 or visit their website at www.atf.gov/content/explosives/explosives-industry/fireworks

- **All customers without an approved storage location should plan to pick up their products or have it delivered THE DAY OF THEIR EVENT. In the case of a rainout or an event cancellation, all Kellner customers are allowed to temporarily store at our facilities (free of charge) products purchased from us.**
- 18 U.S.C. 845 EXEMPTS Federal, State and Local government entities from most provisions of Federal regulations regarding explosives. Federal, State and Local government entities, or their political subdivisions, will NOT be required to obtain a license or permit to acquire display fireworks. Political subdivisions would include educational institutions operated by Federal, State or Local governments (e.g. public schools). Persons possessing display fireworks on behalf of Federal, State and Local government entities or public educational institutions will not be subject to restrictions so long as their possession is in the scope of their employment. Requirements for storage must always be met. Please call us if you have questions.
- Display Fireworks can only be legally stored in an ATF approved explosive magazine. A request for authorization for temporary storage in a commercial building may be made by submitting a written request to ATF.
- No one but the licensee/permittee will be able to pick up the merchandise UNLESS the RELEASE FORM / AUTHORIZATION FOR PICKUP FORM (enclosed) is provided to us by the licensee/permittee prior to pickup. This must be done every year. Person picking up Display Fireworks must be at least 21 years old.
- ATF LICENSEES: A photocopy of your current license (signed in ink) must be on file with us. Anyone using Type 60 Limited Permit must bring both "A" and "B" Stickers.

TERMS AND CONDITIONS

- We accept payment for shipped orders by major credit cards, PAYPAL or Money Orders.
- Sorry, we do not accept checks without prior approval.
- All orders require a NONREFUNDABLE 50% deposit upon placing, unless being picked up within 4 days.
- Items that are in high demand may require full payment at time of order.
- Deposits will not be refunded if the order is canceled by the customer after 48 hours from placing the order.
- Please note that you, the buyer, are notified that all Fireworks products and their handling, storage, transportation and use have significant risks to life and property. No warranties are expressed or implied.
- Please note that all merchandise on this price list is sold upon the condition that we, the seller, shall not be liable in any civil action for any arrest, accident, or injury occasioned during the transportation, handling, storage, sale, or use of the merchandise.
- We do not anticipate changes, but prices, terms and delivery charges are subject to change without notice.

TERMS AND CONDITIONS (Continued)

- Pennsylvania residents must have a resale license or pay 6% Sales Tax. Out-Of-State customers will also be subject to sales tax when picking up orders for their personal, non-commercial use.
- Most items are in stock all year long, but we may run out of some items. If an ordered item is unavailable, we reserve the right to substitute a similar item of equal or greater value, unless otherwise instructed by the customer.
- We reserve the right to refuse to sell to anyone at any time and to limit item quantities available for sale.
- We strongly encourage all new customers to buy a copy of NFPA 1123: Code for Fireworks Display or NFPA 1126: Use of Pyrotechnics before a Proximate Audience. These codes are required to be followed in many states. They are available from NFPA at www.nfpa.org or by calling 1-800-344-3555.

SHIPPING AND DELIVERY INFORMATION

- All customers are responsible for their freight charges.
- All orders will be shipped out as soon as possible, unless specified by the customer. If you need your product by a certain date, please take into consideration the mailing and shipping time.
- For shipped orders, a handling charge will be added to the freight charge. This will be 5% of the freight charge.

DISPLAY FIREWORKS SHIPPING INFORMATION

Your Vehicle - Fireworks that are sold to customers for personal, non-commercial use and transported by such persons in their personal vehicles are not subject to any hazardous materials transportation regulations. Fireworks sold to customers for commercial use ARE subject to various regulations. Please contact us for more information.

Truck Freight - Freight charges start at \$1,000.00 and go up according to the weight of your order and the distance to deliver. Fuel charges and other factors can affect the cost of deliveries. Delivery usually take 6 to 12 days. Call us to obtain a freight quote.

Kellner's Truck - We can deliver Display Fireworks within a 500 mile radius with our truck. We try to group several deliveries on each trip to keep the delivery costs for each customer as low as possible. We will notify you of the delivery charge for your approval prior to shipment. Planning your delivery for one of our scheduled trips is usually the least expensive way to have your fireworks delivered. If you require delivery on a specific day, grouping with other deliveries may not be possible. The delivery charge is \$3.00 per mile (one way), with a minimum charge of \$395.00. No orders will be shipped on our trucks from July 3rd through July 5th.

B.O.S.S. AERIALS, STICKY MATCH, WATERFALLS & CLOSE PROXIMITY ORDERING INFO

- These items can be purchased with state or local permission for a fireworks or pyrotechnic display or an ATF license or permit for fireworks or explosives.
- These items can be shipped via either FedEx Priority Overnight or FedEx Ground. All shipments are subject to Hazardous Materials handling charges of \$93.00 per box for Express and \$33.00 per box for Ground.
- All B.O.S.S. aerials, sticky match, waterfalls and close proximity pyrotechnics sold by Kellner's Fireworks are classified as UN0431 1.4G Articles Pyrotechnic, except B.O.S.S. salute aerials which are classified as UN0335 1.3G Display Fireworks and cannot be shipped as UN0431.
- All B.O.S.S. aerials and close proximity pyrotechnics sold by Kellner's Fireworks are NOT fireworks (except for B.O.S.S. Salutes) and are not subject to ATF storage requirements.

ELECTRIC MATCH (IGNITERS) ORDERING INFORMATION

- All ordering, purchase and ATF storage requirements for Display Fireworks as listed in the Display Fireworks sections of these instructions DO apply to Igniters.
- Igniters CAN be shipped via FedEx Priority Overnight or FedEx Ground service. They are subject to Hazardous Materials handling charges of \$93.00 per box for FedEx Priority Overnight and \$33.00 per box for FedEx Ground.

SHIPPING PROBLEMS

- All merchandise is carefully and securely packed before it is shipped. Once the shipment is in the hands of the carrier, our responsibility ceases. If your shipment appears to be damaged upon receipt, please have the delivery agent make a notation stating that fact. Any delay may cause you a loss. We cannot honor claims for which a carrier is responsible. All claims for shortages and/or damages must be made within 24 hours of receipt of merchandise.
- Priority Overnight does not guarantee that your order will positively get to you overnight. Please allow a few days for your packages to arrive.
- If you have not received a truck freight order within 2 weeks of shipment, please notify us. If your order is lost or stolen, we will help you notify the freight company to trace your order. The freight company will reimburse you for any lost or stolen packages.
